

## **Statewide Conference Call Summaries**

State EOC/Florida Hospital Association Conference Call, 4/1/20 - Notes

- Abbott Point of Care testing coming to Florida, FDOH will notify when it is available.
- ESS continues to expand the types of information being requested. This information is vital to evaluate and inform models and gain understanding of rates of increase in hospitals, ICU and ventilator demand.
- Changes to Medicare eligibility means most individuals will retain eligibility.
- EMS staff transporting to sub-acute facilities are required to go through the facility screening process, unless it is a cardiac call. EMS staff are screened before they begin their shift, but still should be screened at facilities.
- There are reports of fraudulent masks being sold. BE CAREFUL! Ensure that you are purchasing from a reputable vendor.
- Surge Plans need to be in place and ready to be implemented. A regional approach to managing surge is the most effective.
- Consider long-term planning healthcare workers may be exposed at home and work; in some areas, healthcare workers are choosing to stay at local hotels rather than at home to protect their families.

  ESS is adding more fields daily. Instructions on these new fields available on the AHCA ESS website.
  Hospitals should estimate the number of med surge beds that can be converted to ICU beds. Do not duplicate bed numbers in different categories. Start with highest acuity beds.
- Corporate Representatives can be established to monitor data entry at individual facilities. Contact AHCA for assistance.

#### **ELDERLY & VULNERABLE PROTECTION** Protect the elderly by increased mitigation

and messaging at assisted living centers, nursing homes, and other special facilities.



#### PREPARE HOSPITALS

Assess the potential impacts and course of action for hospitals and bed capacity.



SOCIAL DISTANCING Continue to message social distancing.
